


### **UK CONTEXT**





## Gatwick Northern Runway Project

### **BRIEF**

SEC Newgate helped Gatwick Airport engage communities through multiple channels, and across a wide and varied region, as part of its Northern Runway Development Consent Order consultation programme. The UK was emerging from COVID-19 social distancing requirements at the time of planning the consultation. While it was possible to meet in person, many people remained uncomfortable about attending large-scale events. SEC Newgate had to innovate to deliver an inclusive and wide-ranging consultation.

### OUTCOME

sec Newgate used a combination of in-person and virtual engagement methods to encourage participation by a wide range of audiences.

These included taking a Mobile Project Office to over 30 locations across the region, holding 'Call the Expert' events online and by telephone, and hosting online events with more than 350 stakeholder groups. More than 7,500 people participated, with over 5,000 providing feedback.









# A303 Sparkford to Ilchester

### BRIEF

SEC Newgate was appointed to deliver a programme of statutory consultation for Highways England's proposed upgrade of the A303 Sparkford to Ilchester. The scheme required a Development Consent Order (DCO) and had tight timescales.

### OUTCOME


SEC Newgate developed tools for ensuring compliance with the Planning Act 2008, rebuilt relationships with local authority officers, and worked closely with the client to ensure appropriate coordination.

A DCO application was submitted in July 2019, and consent has now been granted.









## **EO** Charging

### BRIEF

SEC Newgate was appointed to support electric vehicle charging company EO Charging with external communications for an initial period of six months. Key objectives included raising its profile and telling its growth story to potential investors and prospective customers.

### OUTCOME

SEC Newgate developed a communications strategy, key messaging, and a communications plan to achieve defined objectives. The work included targeting CEO and business profile opportunities, proactive media pitches, news generation, thought leadership support, content creation for traditional and social media, and the provision of media and political intelligence. The outcome was hundreds of pieces of media coverage, including national and international coverage, and over 15,000 pieces of social media engagement.









# Making the case for the UK to sign the EUROFIMA convention

### BRIEF

Following the UK's exit from the European Union, the UK no longer had access to supranational financing through the European Investment Bank. SEC Newgate was appointed by EUROFIMA to raise awareness of its UK market offer with a view to the UK signing the EUROFIMA convention.


### OUTCOME

SEC Newgate designed and implemented a stakeholder engagement programme targeting decision-makers and influencers. The objective was to raise awareness of the benefits of joining EUROFIMA and secure interest in its competitive rolling stock financing offer. EUROFIMA is now in advanced negotiations with senior officials at the Department for Transport and has secured widespread support.










## Powering Global Travel

### BRIEF

SEC Newgate was appointed to support Expedia Group on its B2B and corporate communications, focusing on its Expedia for Business division. The work included developing high-quality written content, supporting business leaders at industry conferences, and running targeted digital campaigns.

### OUTCOME

The partnership successfully supported the positioning of Expedia Group's fastest driver of growth. SEC Newgate's work included traditional media relations and targeted digital campaigns aimed at niche audience groups.

# A robust and effective consultation strategy

### BRIEF

South Western Railway (SWR) was required by government to consult on proposed changes to its timetable. SEC Newgate developed a robust and effective consultation strategy that met SWR's requirements while standing up to scrutiny from stakeholders. The strategy included preparing and issuing a consultation document, facilitating online workshops, and individual meetings with Members of Parliament and local authorities along the various routes.

#### OUTCOME

SEC Newgate collated and reviewed all responses, preparing a consultation report summarising responses by region, theme, and stakeholder. The report was subsequently shared with participants in the consultation and online. The consultation programme also aimed to protect and enhance SWR's corporate reputation and relationships.
